

#### WHAT IS LEGALINKS?

LEGALINKS is a project that stems from the international experience of its founder, Ms. Anthinea Interbartolo, a young multilingual lawyer, with the aims of promoting an initiative for personal and professional growth among lawyers and other legal practitioners from all over the world and developing together strategies of transnational cooperation.

#### WHICH IS ITS MISSION?

In fact, its mission is to look beyond the micro-world in which each one lives every day, through the creation of LEGALINKS network. Among its activities, there are the so-called CTEs, 'Consulting, Training and Experiencing', i.e. opportunities for legal counselling, career guidance, training as well as practical experiences for present and future practitioners.

# WHICH ARE ITS OBJECTIVES?

## Short-term objectives:

- To count on a trust relationships towards legal professionals belonging to different legal systems;
- To guide possible stakeholders in building an international career profile and in finding a job in demand abroad;
- To prepare international CVs in English/Italian/Spanish/French/Greek;
- To offer online legal workshops enhancing the beneficiaries' knowledge;
- To organise round tables discussions around legal topics with LEGALINKS collaborators;
- To expand the network at national level with lawyers willing to digitalize their profiles.

## Mid/Long-term objectives:

- To promote each member's business within the LEGALINKS website (<a href="https://www.legalinks.net/">https://www.legalinks.net/</a>) in an international environment;
- To provide learning experiences comparing different legal systems;
- To build up an informal and professional dialogue within an international teamwork;



 To facilitate contacts of potential national customers in need of legal assistance in a different legal system.

- Promoted national businesses on the LEGALINKS virtual space;
- Created links between legal businesses in different legal systems;

## WHO CAN JOIN LEGALINKS?

In order to join the LEGALINKS network, the candidates have to accomplish the below requirements:

- Being a qualified lawyer or a person with a legal background from a foreign country (not only EU countries);
- Being under 45 years old;
- Willing to be an international contact person for the LEGALINKS activities;
- Being fluent in English;
- Having curriculum vitae with brilliant working experience in the legal field.

# **HOW TO JOIN LEGALINKS?**

Candidates who accomplish the above-mentioned requirements can join the LEGALINKS teamwork, by filling up the following application form:

Furthermore, a picture, an updated curriculum vitae and a motivation letter (no more than 200 words) showing the interest in joining the network should be included in the application form.

LEGALINKS is not an association nor an enterprise, but it is a virtual space, where lawyers and legal practitioners from all over the world keep their own autonomy and freedom to participate in the future events.



Unfortunately, not every professional can join the project. The LEGALINKS collaborations are limited and selection processes are conducted with transparency, after having assessed the accomplishments of minimum requirements, the CV and the motivation letter.

### WITHDRAWAL OR RENOVATION OF COLLABORATION

The LEGALINKS members are free to withdraw their participation within the network whenever they want, by informing the coordinator of the project, Ms. Anthinea Interbartolo, by email (legalinks.net@gmail.com), at least one month before; after that, the technical team will immediately delete the member's profile on the LEGALINKS website in the related section.

Anyway, withdrawing the participation does not mean that in the future a new application form could not be sent. The collaborators may change every year, based on a turnover system and on expanding the network in different directions and in a dynamic way.

#### LEGALINKS EVALUATION

The project will constantly grow thanks to the contribution that each professional will eventually bring. Any recommendation or suggestion is welcomed for the LEGALINKS growth; for this purpose, anyone interested in the project can get in contact with the responsible team by email at <a href="legalinks.net@gmail.com">legalinks.net@gmail.com</a> and an online meeting can be set up to discuss further details.

In addition, once per year it could be sent to all the LEGALINKS members an evaluation form, asking feedback about the personal LEGALINKS experience and the future intentions.

# LEGALINKS EVENTS

The founders will organize at least once per year an open online event where every member is free to join, to share ideas, to propose new projects, to promote the network and its collaborators' businesses to discuss possible events to organize. The meeting will not last more than 1 hour and 30 minutes. Not all the LEGALINKS professionals have to join it, participation is voluntary.
